Terms and Conditions

This contractual letter serves as formal confirmation of your intent to purchase a beef animal from Market Drayton Market for participation in the Young Stockpersons Competition 2025. Please review the terms and conditions outlined below carefully, as they become legally binding upon signing and submission.

1. I acknowledge that Market Drayton Market Ltd, located at The Agricultural Centre, Market Drayton Livestock Market, Adderley Rd, Market Drayton TF9 3SW, remains the legal owner of the animal throughout the process.
2. I accept responsibility as the registered keeper of the animal and will ensure all necessary paperwork is completed to comply with cattle movement regulations.
3. I agree to present the animal for sale at Market Drayton Market's Christmas Fat Stock event on Wednesday, 3rd December 2025.
4. I understand that Market Drayton Market Ltd will recover the initial purchase cost of the animal from the proceeds of its sale on Wednesday, 3rd December 2025.
5. I acknowledge that I may purchase a beef animal at a maximum price of £2,000, with no purchases permitted above this amount.
6. I agree that, on the day of purchase, the animal must be weighed and photographed before leaving Market Drayton Market.
7. I understand that if the holding where the animal is kept is under TB restrictions on Wednesday, 3rd December 2025, the animal cannot be presented for sale, and my entry into the Young Stockpersons Competition will be rendered null and void.
8. In the event of TB restrictions, I will immediately notify Market Drayton Market Ltd and arrange for the animal to be sold via a Red Market, Orange Market, or Private Sale, as advised by an Auctioneer at Market Drayton Market. This sale must be completed by 11th December 2025.
9. I acknowledge that if the animal dies between the date of purchase and 3rd December 2025, I must notify Market Drayton Market Ltd immediately and will remain fully liable for the full purchase price, payable within 21 days of the date of death.
10. If I purchase a heifer and she becomes in-calf, I understand that my expenses will be covered under the Livestock Auctioneers' Association (LAA) Conditions of Sale, and my entry into the Young Stockpersons Competition will be null and void.
11. I acknowledge that the Young Stockpersons Competition is judged based on a points system, which considers the method of purchase and performance in Classes 1, 2, and 3.

Classes (The top 5 in each class will be awarded 1-5 points, e.g. 1st 5 points)

1. Method of Purchase
2. Best Handler
3. Most Weight Gained over Market Scales
4. Best Presentation of Animal
5. Overall Champion
